Our goal is to treat any personal information you provide to us with the utmost respect and in strict accordance with this Privacy Policy. ### **If you visit our Web site to browse, read or download information:**

You can browse our Web site without telling us who you are or revealing personal information about yourself. In this case our Web servers automatically collect and store: the name, domain, and host from which you access the Internet; the Internet protocol (IP) address of the computer you are using; the browser software you use and your operating system; the date and time you access our sites; and the internet address of the site from which you linked directly to our sites.

We may use your IP address to assist in correcting server problems and to administer our web site. Additionally, we may use this information for statistical purposes, such as determining user demographics for advertising purposes.

We may use this information only as anonymous aggregate data to determine the number of visitors to different sections of our sites, to ensure the sites are working properly, and to help us make our sites more useful. We do not use it to track or record information about individuals.

If you are browsing, a cookie or tracking mechanism is used to help us measure the number of visits, time spent, pages viewed and other Web site statistics. This cookie, by itself, does not reveal to us your email address or who you are.

Cookies are small pieces of data stored by your internet browser on your computer's hard drive. They cannot be used to collect data from your hard drive or to obtain your email address or personal information about you. You may set your browser to notify you when you receive a cookie or to prevent cookies from being sent. Please note that when you block the acceptance of cookies you limit the functionality we can provide when you visit our site.

### **Information Request Forms**

Our web site's information request forms may require users to provide us with contact information (such as name, e-mail and postal address), unique identifiers (such as a Tax ID number) and demographic information (such as zip code and address).

All collected information is used solely for processing potential appointments and insurance quotes. No information is given or sold to third parties for any purpose.



QEO may disclose your personal information among its affiliated businesses and with third-party service providers acting on QEO's behalf. However, QEO will not sell, rent or lease your personal information. The personal information you provide may be transmitted, used, stored and otherwise processed outside of the country where you submitted that information, including in jurisdictions that may not have data privacy laws that provide equivalent protection to such laws in your home country.

### **Security and protection of Information**

QEO uses authentication tools to protect your personal information. The information you may provide through our Web site is secured using industry standard security matters to protect the loss, misuse or alteration of the information under our control. While there is no such thing as perfect security on the Internet, we will take all reasonable steps to ensure the safety of your personal information. In addition, our employees are instructed that such information is to be used only in accordance with the principles of this Privacy Policy and the laws applicable to each specific business.
